Observation: Staff do not have criminal record checks completed through the Criminal Record Review Program of BC.				
Actions taken or to be taken by Registrant (Operator): The registrant is required to complete criminal record checks through the Criminal Record Review Program for all staff.				
The registrant must ensure any new staff hired have completed the appropriate criminal record check before starting work.				
The registrant is to notify the Registry in writing to confirm criminal record checks have been completed.				
Actions taken or to be taken by Registry: Monitor and follow up with the registrant on their progress in completing criminal record checks.

Compliance Action: The registrant has provided an updated residency agreement and documentation indicating that these meals are being provided.	
Observation: The registrant was unable to provide a menu plan for assisted living residents. Lunch and dinner were not provided to assisted living residents.				
Actions taken or to be taken by Registrant (Operator): The registrant must provide a meal plan and meals to all assisted living residents. The registrant must submit an updated residency agreement and supporting documentation indicating that residents are receiving meals each day. No further action required.
