Requirement: Section 28 (3) (a): Opioid overdoses. A registrant must ensure that naloxone and related supplies are readily accessible to all employees and residents.			Compliance Action: Registrant has provided evidence that naloxone kits are readily assessable to residents and employees.			
Observation: Naloxone kits were stored in the medication room and not accessible to employees and residents. Some naloxone kits on-site were expired.			Registrant has updated their opioid overdose plan to include regular monitoring of naloxone kit stock and expiry dates.			

Actions taken or to be taken by Registrant (Operator): Registrant is updated the opioid overdose plan to include monitoring of naloxone kit stock and expiry dates.

Registrant it to ensure that naloxone kits are available on each floor of the residence, in an assessable space where residents and employees can access easily.

Compliance Action: Registrant submitted updated medication policies which now include regular monitoring of medications and returning medications to the pharmacy.			
Observation: Resident (unscheduled) medications were found to be expired with no current medication direction available.						

Actions taken or to be taken by Registrant (Operator): Registrant is required to update medication policies to include regular monitoring of scheduled and unscheduled medications to ensure that medications have not expired. The policy must also include information regarding disposable of expired medication.
