**Observation:** Admission screening documents for a resident did not contain accurate information to determine if the person required care.

No documentation was provided to the Registry demonstrating how the resident was screened for suitability on the day the resident started residency.

Actions taken or to be taken by Registrant (Operator): Registrant to submit a revised admission screening form and admission screening policy that outlines how a resident is screened for suitability for assisted living on the day they arrive at the residence. Admission screening documents are to be signed by the person completing the screening.

**Actions taken or to be taken by Registry:** No further action.
